NOTICE CUM ADDENDUM TO THE SCHEME INFORMATION DOCUMENT (SID) AND KEY INFORMATION MEMORANDUM (KIM) OF EXISTING SCHEMES OF TAURUS MUTUAL FUND.

Changes in the features of Schemes of Taurus Mutual Fund (not amounting to change in the Fundamental Attribute):-

This is to inform that in order to bring uniformity in the practice across Mutual Funds and to standardize the scheme categories and characteristics of schemes, SEBI vide its circular no. SEBI/HO/IMD/DF3/CIR/P/2017/114 dated October 06, 2017 and SEBI/HO/IMD/DF3/CIR/P/2017/126 dated December 04, 2017, has issued detailed guidelines for categorization and rationalization of Mutual Fund schemes. Accordingly, following changes will be carried out in certain schemes of Taurus Mutual Fund to align the same with the requirements specified in the aforesaid circular. The Board of Directors of the Taurus Asset Management Company Limited (the AMC) and the Taurus Investment Trust Company Limited (the Trustees) have approved the following changes which will be effective from **March 23, 2018**. Further, it may be noted that SEBI has vide letter no. IMD/DF3/OW/P/2018/7605/1 dated March 09, 2018 granted its no-objection to the said changes:

However, pursuant to the above SEBI circular, there is a change in Fundamental Attribute in Taurus Bonanza Fund, Taurus Discovery Fund and Taurus Infrastructure Fund. Accordingly, necessary advertisement / communication will be released / intimated separately.

As per SEBI circular dated October 06, 2017, the change in 'Type of Scheme' would not be considered as a change in fundamental attribute.
