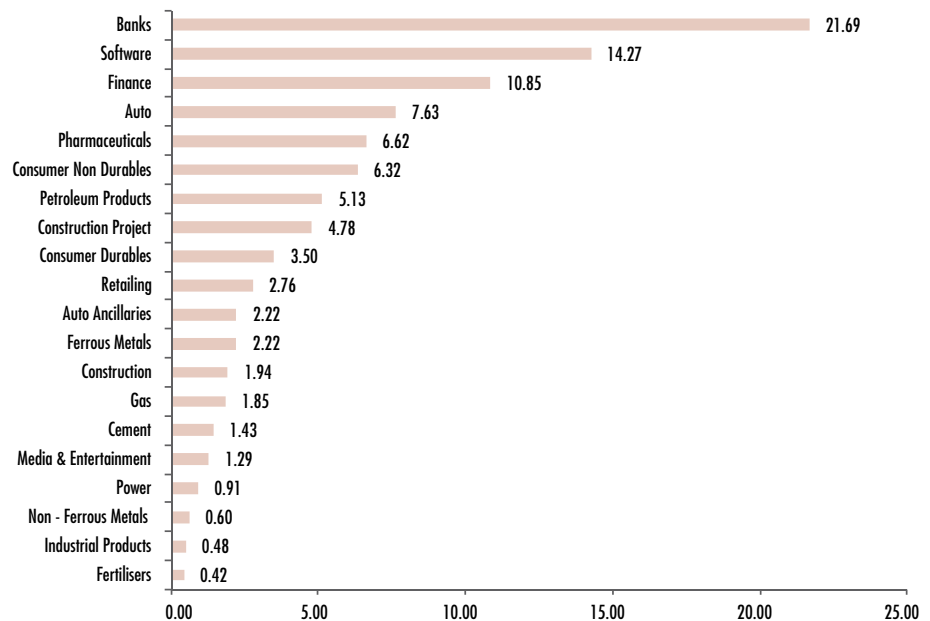

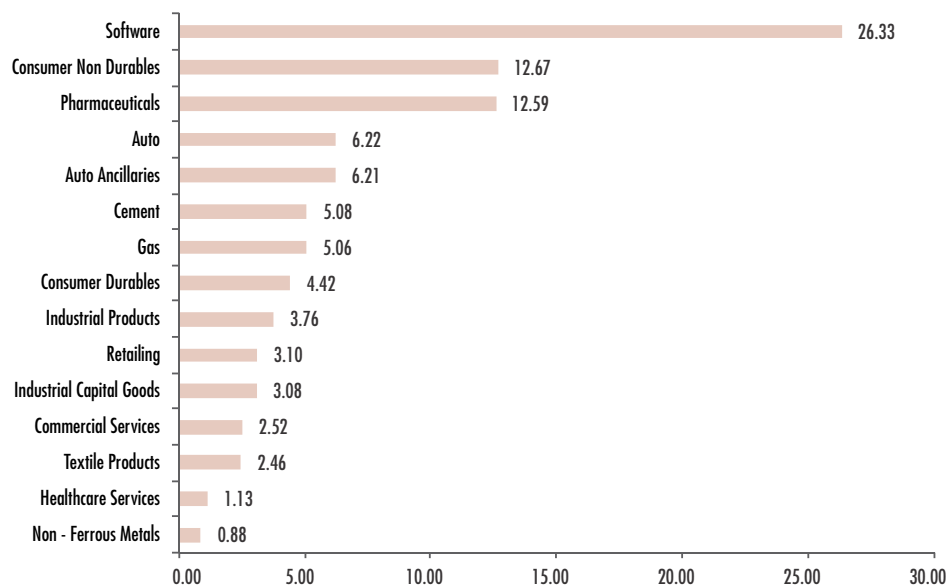

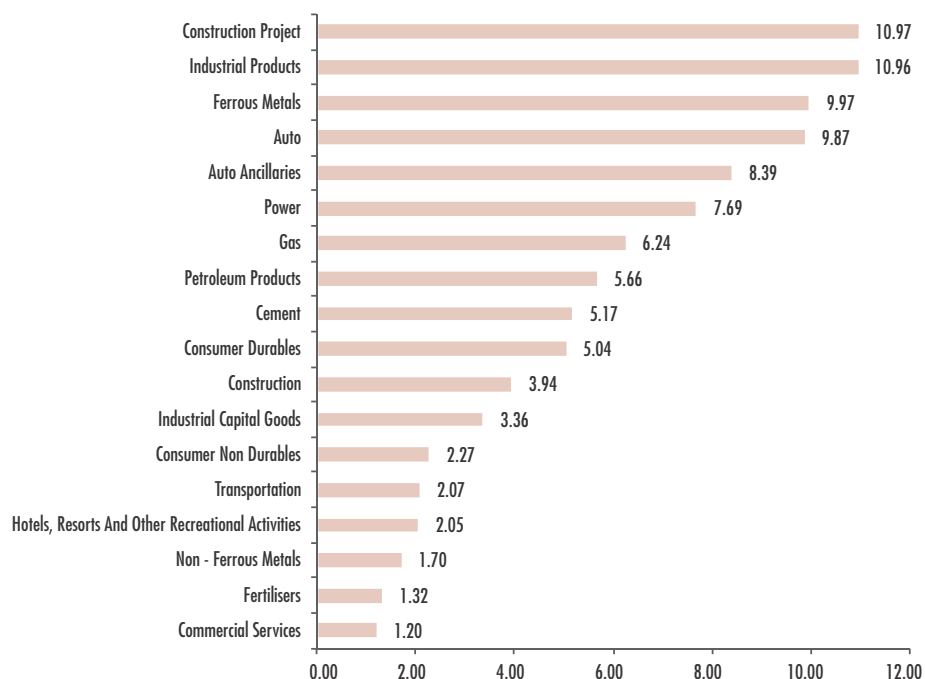

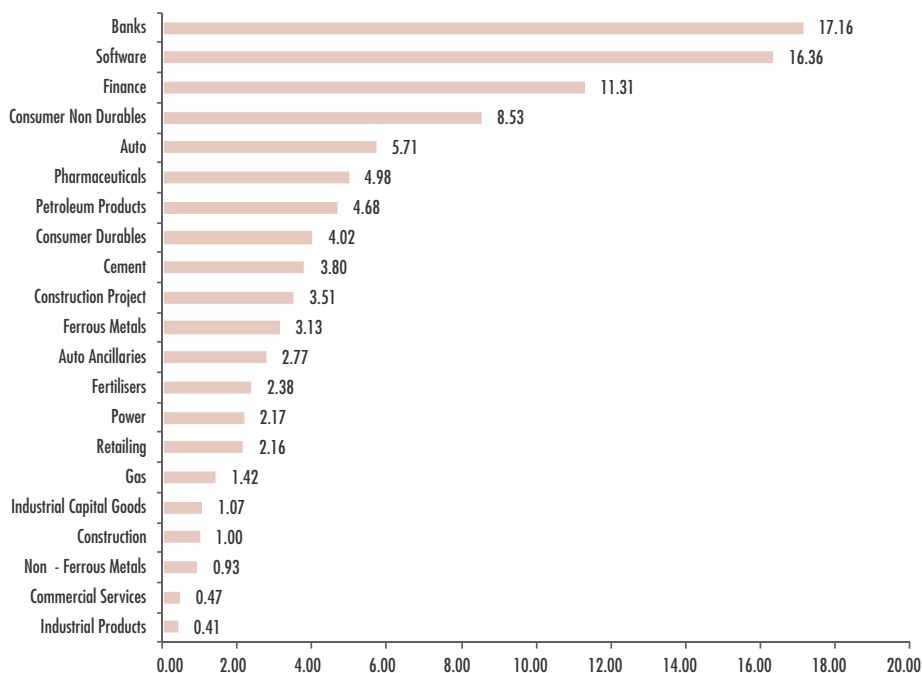

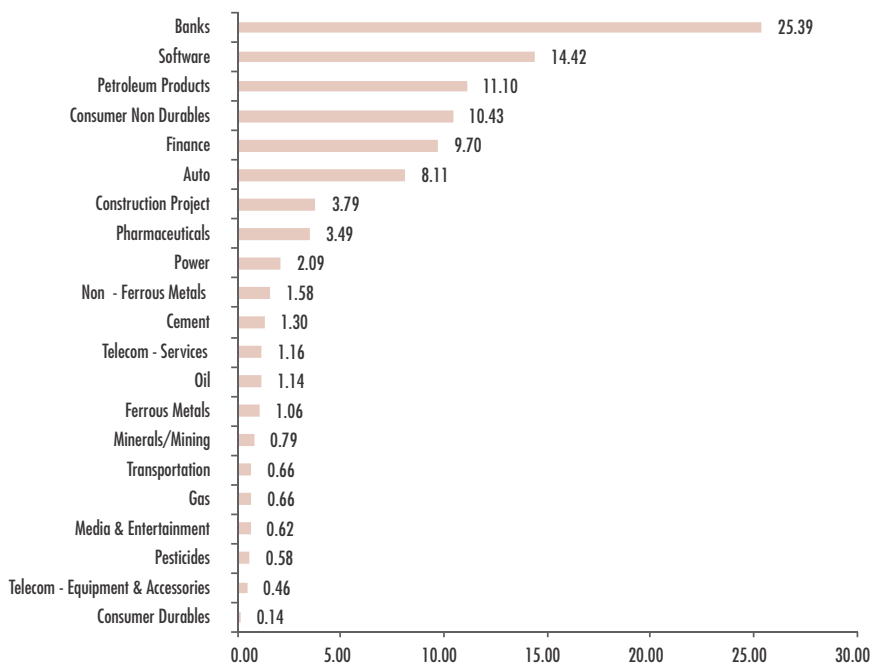

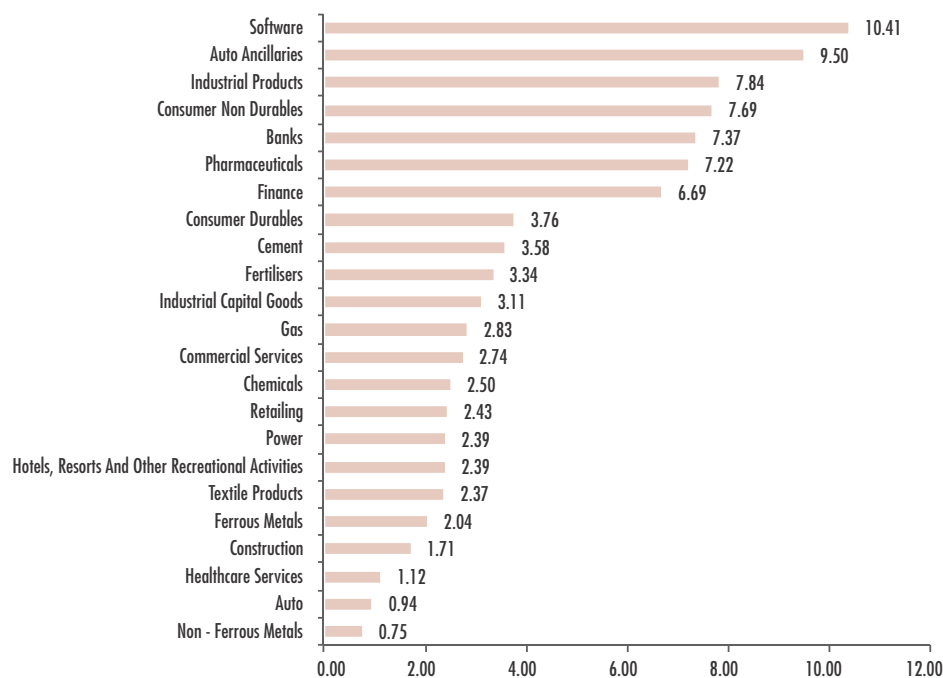

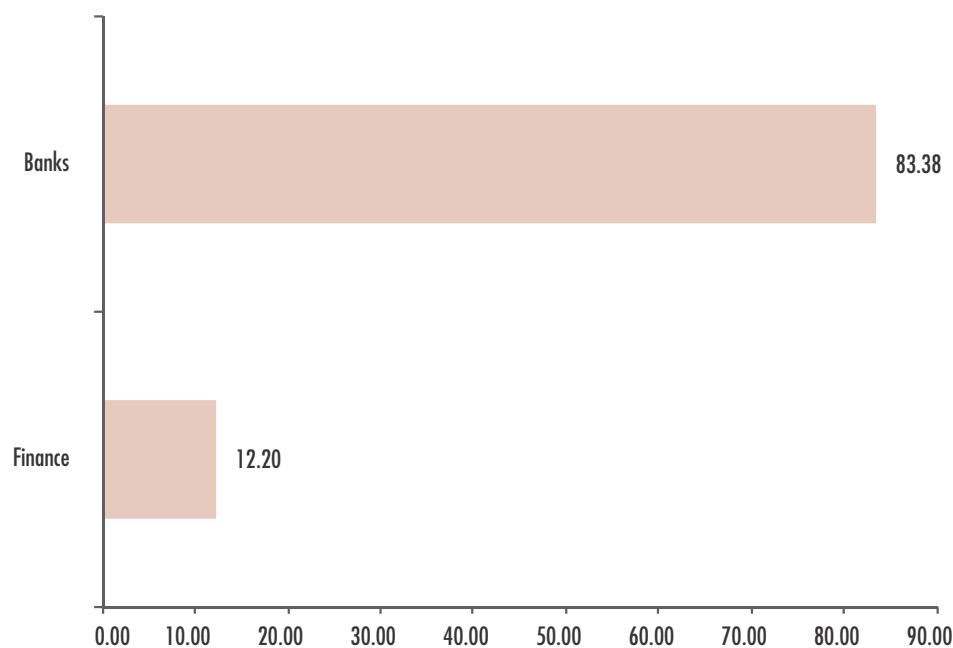

We have maintained a positive bias on Private Banks given their resilience to generate profitability in stressed times. In PSU banks the exposure has been restricted to larger players with relatively improving asset quality outlook and faster prospects of stabilisation.

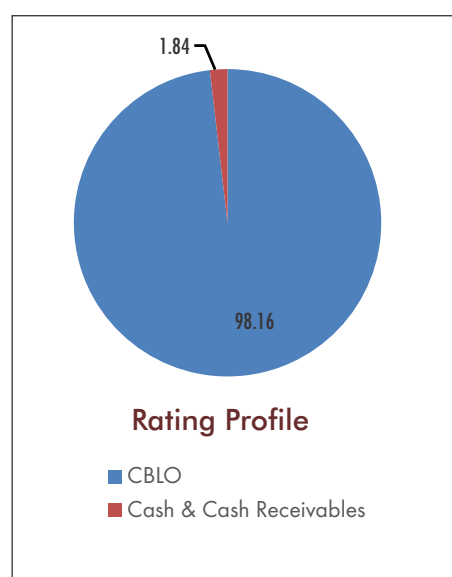
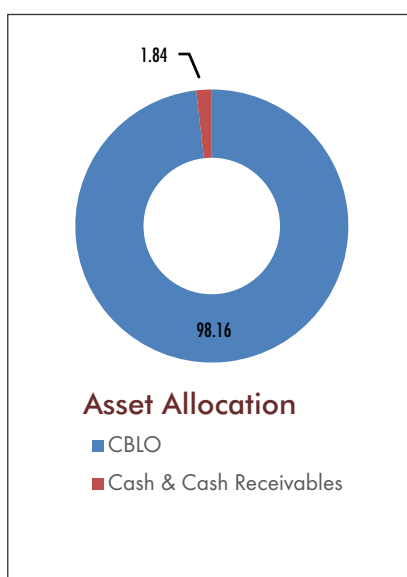

Fund Manager's Comment (Equity Schemes):

Equity markets were in a buoyant mood in August (up 3%) as strong global cues and satisfactory 1QFY19 results played above the concerns of a weakening currency amid deteriorating CAD. August' 18 saw Nifty scaling all time high and is trading at 20x forward earnings; 85% premium to MSCI EM (highest level since 2001).

While the global macro environment continues to remain challenging amidst a) continuing trade war concerns, b) protectionist rhetoric from US (threatening to withdraw from WTO), c) elevated crude prices and d) declining economic growth outlook in Japan, France, Brazil and South Africa, markets found cushion from improving earnings outlook, and sharply improved GDP (8.2% Q1 FY19). Such growth shall improve the overall fundamentals of economy and also reflect in improving corporate earnings. Benefits of govt reform measures yet to play out in economic and corporate earnings growth. With consumer spending improving and capex cycle yet to pick-up, economy is all-set to grow at sturdy pace in medium term. Expect this growth factor to outweigh majority of the global headwinds in medium term.

Fund Manager's Comment (Fixed Income Schemes):

Significant developments/data releases in August 2018 were as under:

- India's real GDP growth for the first quarter of FY 2018-2019 came in at 8.2%, well above expectations. This was higher than the 7.7% growth witnessed in the previous quarter.
- Nominal GDP grew at a rate of 13.8%. Real Gross Value Added grew at a rate of 8%.
- Fiscal deficit for the period April-July 2018 widened to 5.40 lakh crores which is about 86% of the full year's budgeted estimates.
- The month also witnessed sustained pressure on emerging market economy currencies. The Turkish Lira and the Argentine Peso suffered sharp depreciation in value against the US dollar.
- The Indian Rupee (INR) too fell in tandem with other currencies and hit a low of 71 to the US Dollar, during the month.
- The result of sharp currency depreciation is that retail prices for petrol and diesel hit all time highs in almost all major cities of the country.
- India's Consumer Price-based inflation for the month of July came in at 4.17% slightly less than market consensus. Core CPI, which excludes food and energy components also moderated and stood at 6.28% compared to 6.43% in June.
- Wholesale inflation for July came in at 5.09%, lower than 5.77% registered in June. Core WPI stood at 4.74%, as compared to 4.76% in June.
- Yoy growth in the index of industrial production (IIP) for the month of June came in at a four month high of 7%. This figure stood at 3.2% for the month of May.
- India's trade deficit widened to a five year high and stood at USD 18.02 bn in July compared to USD 11.45 bn a year ago. Consequently, trade deficit in the April-July period widened to USD 63 billion as against USD 51.5 Bn a year ago. Imports rose 28.8% to USD 43.79 bn while exports jumped 14.3% to USD 25.77 bn in July 2018
- Early in the month, RBI's monetary policy committee, in a 5-1 decision, voted to increase policy interest rates by 0.25% while reiterating the overall policy stance as "neutral".
- With this increase RBI's repo rate now stands at 6.50%. The reverse repo rate stands at 6.25% and the Marginal Standing Facility is available at 6.75%
- Inflation for the second half of FY 2018-19 has been projected at 4.8% (4.7% previous). Inflation for the first quarter of FY 2019-20 is projected at 5%.
- Growth projection for FY 2018-19 was maintained at 7.4%. Growth in Q1 of FY 2019-20 is projected at 7.5%.
- The benchmark 10 year government bond closed the month trading at a yield of 7.95%, higher by 15 basis point from the closing levels of the previous month.
- Yield on 10 year AAA PSU bond traded at approx. 8.60%, a rise of 2 basis points from the previous month.
- One year CDs yielded about 8.00%, unchanged over the month.

How to read Factsheet

Fund Manager : An employee of the asset management company such as a mutual fund or life insurer, who manages investments of the scheme. He is usually part of a larger team of fund managers and research analysts.

Application Amount for Fresh Subscription : This is the minimum investment amount for a new investor in a mutual fund scheme.

Minimum Additional Amount : This is minimum investment amount for an existing investor in a mutual fund scheme.

Yield to Maturity : The Yield to Maturity or the YTM is the rate of return anticipated on a bond if held until maturity. YTM is expressed as an annual rate. The YTM factors in the bond's current market price, par value, coupon interest rate and time to maturity.

SIP : SIP or systematic investment plan works on the principle of making periodic investments of a fixed sum. It works similar to a recurring bank deposit. For instance, an investor may opt for an SIP that invests Rs. 500 every 15th of the month in an equity fund for a period of three years.

NAV : The NAV or the net asset value is the total asset value per unit of the mutual fund after deducting all related and permissible expenses. The NAV is calculated at the end of every business day. It is the value at which the investor enters or exits the mutual fund.

Benchmark : A group of securities, usually a market index, whose performance is used as a standard or benchmark to measure investment performance of mutual funds, among other investments. Some typical benchmarks include the Nifty, Sensex, BSE200, BSE500, 10 - Year Gsec.

Entry Load : A Mutual fund may have a sales charge or load at the time of entry and/or exit to compensate the distributor/agent.

Entry load is charged at the time an investor purchases the units of a mutual fund. The entry load is added to the prevailing NAV at the time of investment. For instance, if the NAV is Rs. 100 and the entry load is 1%, the investor will enter the fund at Rs. 101

Note: SEBI, vide circular dated June 30, 2009 has abolished entry load and mandated that upfront commission to distributors will be paid by the investor directly to the distributor, based on his assessment of various factors including the service rendered by the distributor.

Exit Load : Exit load is charged at the time an investor redeems the units of a mutual fund. The exit load is reduced from the prevailing NAV at the time of redemption. The investor will receive redemption proceed at net value of NAV less Exit Load. For instance if the NAV is Rs. 100 and the exit load is 1% the investor will receive Rs.99.

Modified Duration : Modified duration is the price sensitivity and the percentage change in price for a unit change in yield

Standard Deviation : Standard deviation is a statistical measure of the range of an investment's performance. When a mutual fund has a high standard deviation, it means its range of performance is wide, implying greater volatility.

Sharp Ratio : The Sharp Ratio, named after its founder, the Nobel Laureate William Sharpe, is a measure of risk-adjusted returns. It is calculated using standard deviation and excess return to determine reward per unit of risk.

Beta : Beta is a measure of an investment's volatility vis-a-vis the market. Beta of less than 1 means that the security will be less volatile than the market. A beta of greater than 1 implies that the security's price will be more volatile than the market.

AUM : AUM or assets under management refers to the recent / updated cumulative market value of investments managed by a mutual fund or any investment firm.

Holdings : The holdings or the portfolio is a mutual fund's latest or updated reported statement of investments/securities. These are usually displayed in terms of percentage to net assets or the rupee value or both. The objective is to give investors an idea of where their money is being invested by the fund manager.

Nature of Scheme : The investment objective and underlying investments determine the nature of the mutual fund scheme. For instance, a mutual fund or growth fund. Likewise, a mutual fund that aims at capital preservation by investing in debt markets is a debt fund or income fund. Each of these categories may have sub-categories.
